The undersigned organizations enthusiastically support the nominations of Brian D. Montgomery for

Deputy Secretary of the Department of Housing and Urban Development (HUD) and David C. Woll, Jr., for Assistant Secretary of the Office of Community Planning and Development (CPD). We urge votes on their nominations by the full Senate as soon as possible.

Mr. Montgomery's long and comprehensive experience at HUD will greatly benefit the administration of the Department. While serving as Federal Housing Administration (FHA) Commissioner from 2005to mid-2009 – under both the George W. Bush and Obama Administrations – Mr. Montgomery realized the immense counter-cyclical benefits that FHA can provide in the middle of the housing crisis. He also led HUD's response to Hurricane Katrina and chaired the Hurricane Recovery and Response Center at HUD headquarters. He is a long-time public servant, having held counsel positions with HUD, the Securities and Exchange Commission, the U.S. Attorney's Office for the District of Columbia, and worked on disaster recovery for the Governor of New Jersey in the aftermath of Hurricane Sandy. This extensive experience will serve the beneficiaries of CPD well.
